PCC celebrated 50 years in 2018.

Ideas for the celebration started percolating towards the end of 2016. Should we, or shouldn't we? If we celebrate, how should we do it? What form ought it take? Go big? Remain low-key? Who would plan? Who would implement? How much? How wide a net to cast in contacting former members? These kinds of questions rumbled through a few heads for a number of months.

After many conversations a plan began to merge. This plan, with a budget, was presented at our Congregational Meeting in 2017. We would embed "50 Years" into the ongoing life of PCC throughout the calendar year of 2018. Beginning in January with a look over our shoulder to the founding of PCC, we would move through 2018 remembering the enduring goodness of God in all things. The plan was approved ... and God blessed us mightily!

On January 14, we took a look at our beginning, complete with a printed history of PCC.

On the weekend of July 21-22, we celebrated "Homecoming." On Saturday our sanctuary was filled with the joyful hum of renewed fellowship as we gathered for a catered brunch. Pictures were taken. Memories were shared. Praise to God was gladly given. Our Worship Assembly on Sunday was a true celebration!

On September 9, we entered into our 'Program Year' (September – June) with a congregational picnic. The weather was a littler cooler than the previous year, but the large tent, catered lunch and "Bounce House" helped to make the day a joyful success.

Finally, came Ingathering on November 18. The Mission Team chose to help one of PCC's first Ingathering recipients, Marilyn Barr and the K.I.N.D.L.E ministry in Malawi. Ingathering simply could not have gone better. A record amount, over \$24,000, was given! God has been so amazingly gracious and generous to PCC. I am humbled and glad to report God's blessings towards us continue.

Each generation has a responsibility to serve God in their place in their time among the people God has appointed for them. The founders of PCC did this. Our current Elders have diligently been praying and looking to the next 50 years. In 2019, and going forward, we are not the same people living in the same culture as when PCC began with ten people. They faced their challenges. Our challenge ... and tremendous opportunity! ... is to trust God and follow Him into the next 50 years.

Elder Team Report 2018

Trust in the LORD with all your heart; do not depend on your own understanding. Seek His will in all you do, and He will show you which path to take. (Proverbs 3:5-6)

As 2017 came to a close, we carried forward our work of "fine tuning" our vision statement which would then guide us to further develop and implement our mission statement. Our vision statement going into 2018 was "Growing closer to Christ. Going further for Christ". This simple statement is not anything new as far as Christian growth and service is concerned but provides a simplified catchphrase to help us focus as individuals and as a church. That initial statement was abbreviated even more, so that we now look at our Vision Statement as "**Grow and Go**".

From this vision our Mission Statement was developed: "Growing together in the grace, love and peace of Christ, we desire to be a church family that glorifies God. Empowered by the Holy Spirit we go joyfully to make disciples, sharing the gospel at home and around the world". Reflecting on this statement reminds us that Christian Growth comes with a purpose—that we are to Go forth and expand God's kingdom to the ends of the earth. Conversely, not growing can often be a symptom of something beneath the surface. Self examination can be a tough and, at times, a painful process. Yet it is good for us to ask ourselves if we are growing in Christ personally and as a church. Are we still making spiritual goals? Are we stuck? Is the experience at our church one that fosters both growth in our personal walk with the Lord and a desire to reach out with the gospel to those within our sphere of influence. This certainly has not been an easy process nor was it taken lightly, but it has helped us to sharpen our focus.

Along with our vision and mission statements a new logo was developed, with the aid of a professional designer, to further clarify our vision. The idea of a stone being dropped into a calm pool and watching the small ripples move out from that stone is a picture of spreading the gospel to our community and beyond. The large "C" in the logo can **PERINTON** be viewed as our community where we reside and cast our influence.

It was our privilege in 2018 to interview and welcome 11 new members into the fellowship of PCC. At the same time we also grieved the passing of three long time members namely, Helen Matthews, Bob Peterson, and Bob Easley. All have had a long history with PCC and served in various capacities. Helen, along with her late husband Bill, was one of the founding members. Bob Peterson had served for many years as a Trustee and treasurer. Bob Easley was involved in different leadership roles to include chair of Elders and Trustees for many years. We certainly have been blessed by them.

On May 25th, PCC had the privilege of holding an ordination service for Mike Skifstad. We certainly have been blessed by him over the 10 years that he and Christina have been with us.

The Elders would also like to express our gratitude to two members of our team that have stepped down. Chuck Vogt has resigned from the Elders after numerous years in leadership and as an Elder. Jerry Fuhrman has completed 6 years as an Elder (3 of which were as chair of Trustees). They will be missed by the rest of the team but I know they will welcome **their** rest. At the same time we also welcome Greg Peck as our newly elected Elder member. Greg has been part of PCC since his childhood and has served in our youth ministry, as a trustee and is part of the praise team.

Trustee Board

The Trustees of Perinton Community Church have the responsibility of managing the finances of our corporate body, paying our bills, maintaining our property, building, and equipment, and projecting and planning for our future needs. We trust the Lord to guide us in our efforts. He has abundantly blessed us with an involved and generous congregation.

Financially, the past year has turned out extremely well. Income was about \$554,000, which exceeded the 2018 budget by over \$54,000. And expenses were about \$12,000 below budget. This even while the Deacons, Pastors and congregation have continued to grow programs and enhance the attractiveness of the church as we rejoiced in celebrating our 50th anniversary.

While the Trustees have been anticipating significant repairs and improvements in the main entryway and foyer, the engineering studies preliminary to such a project have pointed us to drainage and structural deficiencies which should first be addressed. During 2018, larger rain gutters have been installed and the underground drainage network has been analyzed. Improvements to the underground system will be done in 2019.

Also during 2018, the lower parking area has been regraded and paved so that it is now much better than just a muddy overflow lot.

At the Fall, 2018 Congregational Meeting, the Trustees proposed, and the membership approved, an operating budget of nearly \$525,000 for the new year. This will support salary increases for our Pastors and staff; increased missions contributions; increased costs of utilities, programs and office operations; and an increase in the escrow of funds for the necessary maintenance and improvements that are envisioned in the main entry area.

Deacons Team 2018

We are grateful for the many individuals that have stepped up to coordinate or help in the various functions and ministries at PCC. As Deacons we are tasked with oversight of these ministries but not necessarily leading them. Our primary objective is to keep a "pulse" on what is taking place at PCC and assist in the various ministries when called upon. We also spend concentrated time on planning out the coming year as well as evaluating events and ministries of the past year. Though we are not a large church a lot is happening at PCC and volunteers are always appreciated. So please consider being a part of our ministry team. It would be greatly appreciated.

As the physical aspects of our welcome center were completed with placement of furniture and TV monitors, further steps were taken to aid in connecting with new comers. New comer questionnaires are available along with a welcome gift. Church directories are also available as well as general information from one of the volunteers at the desk.

January is the time the Deacons lay out special event plans for the year ahead, with details being addressed the closer we come to the actual event. For 2018 we had:

- **February 9**th Movie night with popcorn and the 9 Square game for the youth.
- March 9th Pinewood Derby which included, for the first time, a race event for the adults.
- March 23rd -24th Passion Play with light refreshments following.
- In May PCC partnered with Fairport Baptist Home to provide a meeting place, and to help with advertising for their four part series entitled, "You Don't Have to do it Alone". PCC also provided set up and refreshments for the four evenings.
- June 2nd Family night outdoor event called PCC Double Dare. PCCers that had the most fun were those that didn't mind getting wet, having cream pie thrown on them, raw eggs smashed on their heads and a few other such things. A visit from an ice cream truck made the evening all worth it.
- **September 9**th Fall kick-off picnic. This has been a good way to begin the new program year at PCC for the last few years.
- December 16th Mike and DL planned an intergenerational outdoor event for the holidays including a hot chocolate station, a craft making center, a live Nativity (youth) with animals, a bonfire, the Christmas Grinch, a photo booth, a presentation by the children's choir and adult choir, and culminating in the lighting of the large evergreen on the property.

Child protection is a concern for any organization that deals with children. A Child Protection Policy has been in place at PCC for a number of years and we are currently going through updating some aspects of it. Part of the process is to perform a background check on all that work with children. This year we have decided to utilize an online service called "Protect My Ministry" a service that is also used by Flower City Work Camp. This service provides us with the background check results and also a general on line training session.

We are always grateful for those that are willing to be part of the leadership team. I want to thank Hyland Hartsough, who has stepped down, for serving 3 years as one of our Deacons. Hyland is no stranger to leadership at PCC having served in other capacities as well. At the same time, I welcome Bryan Zirkle, Chris Hanchett and Stefanie Thane to the Deacons team.

Mission Team

The mission team works to support our mission family and involve the congregation in mission in our community and around the world. This year we did that with communication with our missionaries and with two major events involving the congregation.

The first was the April celebration for PCC's 50 year anniversary. PCC had a mission Sunday where our missionaries were highlighted with a missionary fair. Each missionary was represented with detailed prayer cards, pictures, displays and information on the many ways that PCC has worked through mission. Many of our missionaries were represented in person as well. The mission team made food to complement the different parts of the world. Gail Schlosser from Pioneers shared with us during the service. It was a wonderful celebration of what God has done through the mission program at PCC.

Our second big event for 2018 was the Ingathering project, Bringing Hope to Malawi. We partnered with Kindle Orphan Outreach and SIM to support a project that provide funds to enable the Tiwale Center to start training students. They would be able to pay for bricklaying tools and supplies, allowance for an instructor for bricklaying, and for carpentry tools and supplies. This was to help them start up for the first three years. PCC raised \$24,265.68, enabling SIM to fund even more of the project to bless the people of Malawi. The congregation celebrated by an evening of music, Africa themed activities for families, as well as our traditional sharing of pies.

We have been very blessed, and the mission team looks forward to serving God in 2019.

Financial activity during 2018 resulted in a net income of \$66,421 (13.3% of budget) compared to a net income last year (2017) of \$38,687! Expenses were 2.4% under budget while income was 10.9% above budget (Praise God!). The 2019 budget of \$524,719 requires an average income of \$43,726 per month which is less than the average 2018 giving of \$46,183 per month (but don't plan to give less!).

Other items of note:

- Ingathering giving for SIM Kenya project was \$24,266 (a new record).
- At EoY 2018 we had a Current Fund Net Worth of \$178,948, which is cash on hand that is not committed to various Funds and Escrows (some of this is required and used to fund day to day operations.)
- There were a number of significant projects and expenditures in 2018: refurbished downstairs bathrooms, a welcoming Welcome Center, new lights for the parking lot, paving the back parking lot, new gutters and studies to address the water drainage problem that is the root cause of floor buckling in the lobby, and a new car for the Treasurer (kidding on that last one but want to see if anyone actually reads this). There are still significant upgrades needed and desired for our facility, and future opportunities to serve God; a healthy cash reserve will make that possible.

A special thanks and memorial to Bob Peterson who served as Lead Counter and a previous Treasurer—he will be missed. Additional thanks to Jenn George, Coralie Hoselton, Ed Marr, Al Soanes, Lisa Giannetti, and Crystal Nickson (new Lead Counter) for their service as Assistant Treasurers this past year.


